# Non-Refundable Puppy Deposit Agreement

This agreement should be signed right after or before sending a deposit

This agreement (“**Agreement**”), dated as of \_\_\_\_\_, 20\_\_ (the “**Effective Date**”), is between \_\_\_\_\_ (“**Breeder**”), and \_\_\_\_\_ (“**Buyer**”). Buyer agrees to place a \$\_\_\_\_\_ deposit (“**Deposit**”) on a [Breed] puppy from Breeder.

1. Non-Refundable Deposit. Buyer acknowledges that the Deposit is non-refundable in all circumstances, including but not limited to if Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the Deposit, Breeder agrees to hold the puppy for Buyer until it has been weaned and is ready for pick up (8weeks old). All payments under this Agreement shall be made in US dollars and paid to Breeder via Venmo, Zelle, Cash, or Good Dog
2. Buyer Acknowledgements. Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the Deposit gives Buyer a “pick” place, but does not guarantee a puppy or that Buyer’s preferences will be available when it is Buyer’s turn to pick; (c) pick places are given on a first-come first served basis and Buyer’s place in line is not negotiable; and (d) Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes an adult.
3. [Buyer’s Right to Transfer/Refund]. Notwithstanding the foregoing, if a puppy that meets Buyer’s identified preferences is not available [when it becomes Buyer’s turn to pick a puppy from the selected litter], Buyer may elect (a) to have the Deposit transferred to the next litter. Buyer has up to three different times to move to different litters.

4. Refund on timeline change. If the buyer joins a waitlist and due to uncontrolled breeding related issues the litter gets pushed off to a later date. The buyer has the options of staying, choosing a different available spot on open waitlists or leaving with a refunded deposit.
  
5. [Refund at Breeder's Discretion. If the buyer pays the Deposit, then later decides s/he does not want the puppy for any reason, Breeder is not required to refund the Deposit. If, however, Breeder is able to sell the puppy to another buyer within a reasonable amount of time after Buyer notifies Breeder of his/her decision, Breeder may (in its sole discretion) refund the Deposit to Buyer.]
  
6. Final Purchase Price. Breeder and Buyer agree that (a) the Deposit shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is shipped and/or ownership is transferred from Breeder to Buyer. [The total purchase price for the puppy \$3500. The foregoing purchase price does not include any delivery or shipping charges.]
  
7. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of [Washington] without regard to the conflicts of laws provisions thereof.
